3	SPECIAL MOTOR VEHICLE REGISTRATION PLATES FOR VIETNAM
4	VETERANS AND TO PROVIDE THAT THE TEN-DOLLAR ADDITIONAL FEE
5	CHARGED FOR THE PLATE WILL BE USED TO SUPPORT THE NORTH
6	CAROLINA VETERANS HOME.
7	The General Assembly of North Carolina enacts:
8	Section 1. G.S. 20-79.4(b) is amended by adding a new subdivision to read:
9	"(28a) Vietnam Veteran Issuable to a veteran of the armed forces of the
10	United States who served in Vietnam. The Division may not issue the
11	plate authorized by this subdivision unless it receives at least 300
12	applications for the plate."
13	Section 2. G.S. 20-79.7(b) reads as rewritten:
14	"(b) Distribution of Fees The Special Registration Plate Account and the
15	Collegiate and Cultural Attraction Plate Account are established within the Highway
16	Fund. The Division must credit the additional fee imposed for the special registration
17	plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the
18	Collegiate and Cultural Attraction Plate Account (CCAPA), and-the Natural Heritage
