5	Section 1. G.S. 20-79.4(b)(13a) is recodified as G.S. 20-79.4(b)(13b).
6	Section 2. G.S. 20-79.4(b) is amended by adding a new subdivision to read:
7	"(13a) Ducks Unlimited Plates. – Issuable to the registered owner of a motor
8	vehicle in accordance with G.S. 20-81.12. The plate shall bear the logo
9	of Ducks Unlimited, Inc., and shall bear the words: "Ducks Unlimited"."
10	Section 3. G.S. 20-79.7(a) reads as rewritten:
11	"(a) Fees. – Upon request, the Division shall provide and issue free of charge one
12	registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled
13	veteran, and an ex-prisoner of war. All other special registration plates are subject to the
14	regular motor vehicle registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee
