1	A BILL TO BE ENTITLED
2	AN ACT TO GIVE ILL AND DISABLED CIVILIANS THE SAME RIGHT AS
3	MILITARY PERSONNEL TO REQUEST ABSENTEE BALLOTS FOR AN
4	ENTIRE CALENDAR YEAR AND BY PRESCRIBING A METHOD FOR
5	MAKING ABSENTEE BALLOT REQUESTS, AND TO REALIGN THE
6	SUPERIOR COURT DISTRICTS IN FORSYTH COUNTY.
7	The General Assembly of North Carolina enacts:
8	<b>SECTION 1.</b> G.S. 163-226 is amended by adding a new subsection to read:
9	"(a2) Annual Request by Person With Sickness or Physical Disability. – If the
10	applicant so requests and reports in the application that the voter has a sickness or
11	physical disability that is expected to last the remainder of the calendar year, the
12	application shall constitute a request for an absentee ballot for all of the primaries and
13	elections held during the calendar year when the application is received."
14	<b>SECTION 2.</b> Article 20 of the General Statutes is amended by adding a new
15	section to read:
16	"§ 163-230.2. Method of requesting absentee ballots.
17	(a) <u>Valid Types of Written Requests. – A written request for an absentee ballot as</u>
18	required by G.S. 163-230.1 is valid only if it is written entirely by the requester
19	personally, or is on a form generated by the county board of elections and signed by the
20	requester. The county board of elections shall issue a request form only to the voter
21	seeking to vote by absentee ballot or to a person authorized by G.S. 163-230.1 to make
22	a request for the voter. If a requester, due to disability or illiteracy, is unable to complete
23	a written request, that requester may receive assistance in writing that request from an
24	individual of that requester's choice.
25	(b) Invalid Types of Written Requests. – A request is not valid if it does not
26	comply with subsection (a) of this section. If a county board of elections receives a
27	request for an absentee ballot that does not comply with subsection (a) of this section,
28	the board shall not issue an application and ballot under G.S. 163-230.1.

6	<b>SECTION 5.</b> This act is effective when it becomes law. Sections 3 and 4 of

8	elections held on or after January 1, 2002. The remainder of this act applies to
9	primaries and elections held on or after January 1, 2002.
