A BILL TO BE ENTITLED

AN ACT TO ESTABLISH HOUSE DISTRICTS.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 120-2 is rewritten to read:

"§ 120-2. House apportionment specified.

(a) For the purpose of nominating and electing members of the North Carolina House of Representatives in 2002 and periodically thereafter, the State of North Carolina shall be divided into the following districts with each district electing one member, except that Districts 1, 10, 13, 16, 17, 20, 21, 23, 28, 29, 34, and 37 each elect two members, and except that Districts 15 and 24 each elect three members, and except that Districts 7, 19, and 31 each elect four members, and except that Districts 5, 9, 11, 18, 25, and 33 each elect five members, and except that District 22 elects six members, and except that District 3 elects seven members, and except that District 26 elects eight members, and except that District 14 elects 10 members:

31 boundary of a senatorial district, which shall remain the same.

32 (e) If this section does not specifically assign any area within North Carolina to a
33 district, and the area is:

- 34 (1) Entirely surrounded by a single district, the area shall be deemed to
35 have been assigned to that district.
- 36 (2) Contiguous to two or more districts, the area shall be deemed to have
37 been assigned to that district which contains the least population
38 according to the 2000 United States Census.
- 39 (3) Contiguous to only one district and to another state or the Atlantic
40 Ocean, the area shall be deemed to have been assigned to that district."

41 **SECTION 2.** This act is effective when it becomes law.
