1	I. Where ABC stores have heretofore been
2	established but in which the sale of mixed
3	beverages has not been approved;
4	II. That borders on a county that has approved
5	the sale of alcoholic beverages countywide
6	and contains an international airport; and
7	III. Borders on a county where ABC stores
8	have heretofore been established by
9	petition pursuant to law; and
10	3. Contains more than 500 contiguous acres made up of
11	privately-owned land and land owned by an
12	association or a club that is exempt from income tax
13	on its membership income under Article 4 of Chapter
14	105 of the General Statutes, has more than 200
15	members, was created for municipal and recreational
