A BILL TO BE ENTITLED

2 AN ACT TO APPROPRIATE FUNDS TO COMMUNITY MEDIATION CENTERS 3 ACROSS THE STATE.

- 4 The General Assembly of North Carolina enacts:
- 5 **SECTION 1.** There is appropriated from the General Fund to the Judicial Department the sum of five hundred five thousand four hundred sixty dollars 6 7 (\$505,460) for the 2001-2002 fiscal year and the sum of five hundred five thousand four hundred sixty dollars (\$505,460) for the 2002-2003 fiscal year for additional funding for 8 9 20 community mediation centers, also known as dispute settlement centers, across the 10 State, and additional funding for the Mediation Network of North Carolina.

11 **SECTION 2.** Of the funds appropriated in Section 1 of this act, fifteen 12 thousand dollars (\$15,000) for the 2001-2002 fiscal year and fifteen thousand dollars 13 (\$15,000) for the 2002-2003 fiscal year shall be allocated for additional funding for the Mediation Network of North Carolina. The remaining funds shall be allocated for the 14 15 2001-2002 fiscal year and for the 2002-2003 fiscal year as follows:
