The Department of Insurance may 17 contract with local inspection departments to conduct inspections under this subsection. 18 19 The Department of Insurance shall revoke a permit issued under this section 20 upon a finding that the requirements for the original issuance of the permit are not being 21 complied with. 22 (f) Appeals of decisions of the Department of Insurance regarding the issuance or revocation of permits under this section shall be in accordance with Chapter 150B of 23 24 the General Statutes. 25 (g) For the purposes of this section, 'business entity' has the same meaning as in 26 G.S. 59-102. 27 In addition to the provisions of G.S. 143-138(h), the owner or operator of any (h) 28 business entity who is issued a permit as a door lock exempt business in accordance 29 with subsection (b) of this section who fails to comply with the permit requirements of 30 subsection (b) of this section shall be subject to a civil penalty of five hundred dollars (\$500.00) for the first offense, one thousand dollars (\$1,000) for the second offense, and 31 32 five thousand dollars (\$5,000) for the third and subsequent offenses, except when the building or facility in which business is conducted is in compliance with the door lock 33 34 requirements of Chapter 10 of Volume 1 of the North Carolina State Building Code. 35 Penalties authorized in this subsection shall be imposed by the city or county in which 36 the violation occurs. Each day the building or facility in which business is conducted is not in compliance with the provisions of this subsection constitutes a separate offense. 37
 - (i) The Department of Insurance shall adopt rules to implement this section."

Any business entity licensed to sell automatic weapons as a federal firearms dealer that is in the business of selling firearms or ammunition or that operates a firing range which rents firearms and sells ammunition that desires to be exempt from the door lock requirements of Chapter 10 of Volume 1 of the North Carolina State Building Code may apply for a permit to do so with the Department in accordance with G.S. 143-143.4 and rules adopted by the Department. The Department shall charge a permit fee of five hundred dollars (\$500.00) for the issuance of a permit issued pursuant to G.S. 143-143.4."

SECTION 3. This act is effective when it becomes law.
