EFFECTIVE DATE: This act is effective when it becomes law.

BILL SUMMARY: The bill authorizes the construction and financing, without appropriations from the General Fund, of capital improvement projects of the constituent institutions of the University of North Carolina.

ASSUMPTIONS AND METHODOLOGY: The chart on the following pages was compiled with the assistance of the Associate Vice President for Finance for the UNC Office of the President. The chart shows the cost to construct and operate the proposed campus buildings and the source of funds for each facility. The effect of the bond debt on students is also shown. With one exception, all projects are scheduled to begin construction in 2003 and have been approved by the Boards of Trustees of the campuses and the UNC Board of Governors. The Student Recreation Center at Western Carolina University was added by the Finance Committee and was not approved by the UNC Board of Governors. UNC General Administration staff received the Western Carolina request, but did not forward it to the UNC Board of Governors because the project was scheduled for July 2003 in FY 2003-04.

The seven projects in Section 3 of the bill were previously authorized by the 2000 General Assembly as part of the \$3.1 billion bond program in SB 912 (S.L. 2000, Chapter 3). These projects have received the following General Obligation bond funding:

Eight projects in the bill will require a General Fund appropriation to fund annual operating expenses. UNC-Chapel Hill's School of Medicine Research Facilities is the first to require operating money in FY 2002-03. Three more facilities require General Fund support in FY 2003-04, two more in FY 2004-05, and two more in FY 2005-06. The average operating cost for these eight buildings is \$11.9 million over the next twenty years.
