A BILL TO BE ENTITLED

AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE A
4-H SPECIAL REGISTRATION PLATE.

Whereas, 4-H is an outstanding youth development program that serves almost 200,000 youth in North Carolina and over 7,000,000 youth nationally each year; and

Whereas, 4-H promotes values, integrity, leadership, and community involvement, serving as a positive influence on the youth of our society; and

Whereas, 4-H has a long and rich history in North Carolina and will celebrate its State centennial in 2009; Now, therefore,

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 20-79.4(b) reads as rewritten:

"(b) Types. – The Division shall issue the following types of special registration plates:

...

(15b) 4-H. – Issuable to the registered owner of a motor vehicle in accordance with G.S. 20-81.12. The plate shall bear '4-H' and the 4-H four-leaf clover logo. The Division may not issue the plate authorized by this subdivision unless it receives at least 300 applications for the plate."

SECTION 2. G.S. 20-79.7(a) reads as rewritten:

"(a) Fees. – Upon request, the Division shall provide and issue free of charge one registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled veteran, and an ex-prisoner of war. All other special registration plates, including additional Congressional Medal of Honor, 100% Disabled Veteran, and Ex-Prisoner of War plates, are subject to the regular motor vehicle registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

2 **SECTION 3.** G.S. 20-79.7(b) reads as rewritten:

3 "(b) Distribution of Fees. – The Special Registration Plate Account and the
 4 Collegiate and Cultural Attraction Plate Account are established within the Highway
 5 Fund. The Division must credit the additional fee imposed for the special registration
 6 plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the
 7 Collegiate and Cultural Attraction Plate Account (CCAPA), the Natural Heritage Trust
 8 Fund (NHTF), which is established under G.S. 113-77.7, and the Parks and Recreation
 9 Trust Fund, which is established under G.S. 113-44.15, as follows:

7 **SECTION 4.** G.S. 20-81.12 is amended by adding a new subsection to read:

8 "(b31) 4-H. – The Division must receive 300 or more applications for the 4-H plate
9 before the plate may be developed. The Division shall transfer quarterly the money in
10 the Collegiate and Cultural Attraction Plate Account derived from the sale of the 4-H
11 plates to The 4-h Club foundation of North Carolina, Inc., to support three initiatives:
12 county 4-H programs in all 100 counties and on the Qualla boundary, the NC State 4-H
13 program, and for repair and renovations at the five 4-H camps and conference centers in
14 this State."

15 **SECTION 5.** This act is effective when it becomes law.
