1 A JOINT RESOLUTION HONORING THE LIFE AND MEMORY OF ELMER  
2 "E.V." WILKINS, FORMER EDUCATOR AND CIVIC LEADER.

3 Whereas, Elmer Vanray "E.V." Wilkins was born on July 4, 1911, to Tom  
4 and Maggie Wilkins in Roper, North Carolina; and

5 Whereas, E.V. Wilkins received his B.S. and M.A. degrees from North  
6 Carolina Central University; and

7 Whereas, E.V. Wilkins taught mathematics in Roper at J.J. Clemmons High  
8 School, which was renamed Washington County Union School; and

9 Whereas, while at Clemmons High School, E.V. Wilkins met the love of his  
10 life, Elizabeth Witherspoon, also a teacher, whom he later married; and

11 Whereas, E.V. Wilkins became principal of Clemmons High School in 1941  
12 and served in that position until 1974; and

13 Whereas, E.V. Wilkins was a mentor to his young students, encouraging them  
14 to attain academic success; and

15 Whereas, in 1946, E.V. Wilkins was instrumental in raising money to  
16 purchase the school's first bus; and

17 Whereas, E.V. Wilkins and the National Association for the Advancement of  
18 Colored People won a major victory in the mid-1950s when the court sided with them in  
19 allowing African-American residents in Washington County the right to vote; and

20 Whereas, in 1967, E.V. Wilkins become the first African-American since  
21 reconstruction to be elected to the Roper Town Council; and

22 Whereas, in 1975, E.V. Wilkins was the first African-American elected as  
23 Mayor of Roper, a position he held for 20 years; and

24 Whereas, E.V. Wilkins was a member of numerous boards, serving on the  
25 State Board of Education, the State Economic Development Commission, the North  
26 Carolina Secondary Road Council, the North Carolina Railroad Board of Directors, and  
27 the North Carolina State Ports Authority; and

1           Whereas, E.V. Wilkins served as a member of the Board of Trustees of the  
2 North Carolina School of Science and Mathematics, the Advisory Board for the Rural  
3 Education Institution at East Carolina University, and of the Elizabeth City State  
4 University Board of Trustees from 1987 to 1994, serving as Chair from 1989 to 1994;  
5 and

6           Whereas, E.V. Wilkins organized and served as director of the  
7 Industrialization Center in Roper from 1974 to 1975; and

8           Whereas, E.V. Wilkins was active in the Democratic party, serving as a  
9 delegate to the National Democratic Convention in 1972, 1980, 1982, and 1986; and

10          Whereas, E.V. Wilkins received numerous honors and awards, including the  
11 North Carolina Distinguished Citizen Award, the Order of the Long Leaf Pine Award,  
12 the Service Award by the North Carolina Leadership Caucus, the North Carolina  
13 Distinguished Service Award, and the North Carolina Human Relations Commission's  
14 Libby D. Koonz Award in recognition of his dedication and leadership in the areas of  
15 education, civil rights, and human rights; and

16          Whereas, E.V. Wilkins was honored by Elizabeth City State University when  
17 the University's computer center was renamed the E.V. Wilkins Academic Computing  
18 Center in 1992; and

19          Whereas, E.V. Wilkins was also honored by the University with the  
20 establishment of the E.V. Wilkins Endowed Chair in the Elizabeth City State University  
21 School of Education and Psychology in 1996; and

22          Whereas, E.V. Wilkins died on June 2, 2002; and

23          Whereas, E.V. Wilkins is survived by his daughters, Bunny Sanders and Joy  
24 Price, son-in-law, Ralph Price, and two grandchildren; Now, therefore,  
25 Be it resolved by the House of Representatives, the Senate concurring:

26          **SECTION 1.** The General Assembly honors the life and memory of Elmer  
27 "E.V." Wilkins and expresses the gratitude of this State and its citizens for service he  
28 rendered.

29          **SECTION 2.** The General Assembly extends its deepest sympathy to the  
30 family of Elmer "E.V." Wilkins for the loss of a beloved family member.

31          **SECTION 3.** The Secretary of State shall transmit a certified copy of this  
32 resolution to the family of Elmer "E.V." Wilkins.

33          **SECTION 4.** This resolution is effective upon ratification.
