## A BILL TO BE ENTITLED

AN ACT TO AUTHORIZE THE SECRETARY OF HEALTH AND HUMAN
SERVICES TO TEMPORARILY WAIVE CERTAIN REQUIREMENTS OF THE
MENTAL HEALTH COMMITMENT STATUTES TO FURTHER MENTAL
HEALTH REFORM EFFORTS.

6 The General Assembly of North Carolina enacts:

**SECTION 1.** The Secretary of Health and Human Services may, upon request of a phase-one local management entity, waive temporarily the requirements of G.S. 122C-261 through G.S. 122C-263 and G.S. 122C-281 through G.S. 122C-283 pertaining to initial (first-level) examinations by a physician or eligible psychologist of individuals meeting the criteria of G.S. 122C-261(a) or G.S. 122C-281(a), as applicable, as follows:

- The Secretary has received a request from a phase-one local 13 (1)management entity to substitute for a physician or eligible 14 psychologist, a licensed clinical social worker, a masters level 15 psychiatric nurse, or a masters level certified clinical addiction 16 specialist to conduct the initial (first-level) examinations of individuals 17 meeting the criteria of G.S. 122C-261(a) or G.S. 122C-281(a). The 18 waiver shall be implemented on a pilot-program basis. The request 19 from the local management entity shall be submitted as part of the 20 entity's local business plan and shall specifically describe: 21
- a. How the purpose of the statutory requirement would be better
  served by waiving the requirement and substituting the
  proposed change under the waiver.
  b. How the waiver will enable the local management entity to

5 6			d. How the health, safety, and welfare of individuals will continue to be at least as well protected under the waiver as under the
7			statutory requirement.
8			e. The method to be used to evaluate the effectiveness and
9			efficiency of mental health, developmental disabilities, and
10			substance abuse services and protection of health, safety, and
11			welfare under the waiver.
12		(2)	The Secretary shall review the request and may approve it upon
13			finding that:
14			a. The request meets the requirements of this section.
15			b. The request furthers the purposes of State policy under G.S.
16			122C-2, and mental health, developmental disabilities, and
17			substance abuse services reform.
18			c. The request improves the delivery of mental health,
19			developmental disabilities, and substance abuse services in the
20			counties affected by the waiver and also protects the health,
21			safety, and welfare of individuals receiving these services.
22			d. The duties and responsibilities performed by the licensed
23			clinical social worker, the masters level psychiatric nurse, or the
24			masters level certified clinical addiction specialist are within the
25			individual's scope of practice.
26		(3)	The waiver granted by the Secretary under this section shall be in
27			effect for a period not to exceed three years, or the period for which
28			the requesting local management entity's business plan is approved,
29			whichever is shorter.
30		(4)	The Secretary may grant a waiver under this section only to those local
31			management entities that have been designated as phase-one entities as
32			of July 1, 2003.
33		(5)	In no event shall the substitution of a licensed clinical social worker,
34			masters level psychiatric nurse, or masters level certified clinical
35			addiction specialist under a waiver granted under this section be
36			construed as authorization to expand the scope of practice of the
37			licensed clinical social worker, the masters level psychiatric nurse, or
38			the masters level certified clinical addiction specialist.
39		(6)	The Department shall assure that staff performing the duties are
40			trained and privileged to perform the functions identified in the waiver.
41		(7)	The local management entity shall assure that a psychiatrist is
42			available at all times to provide back-up services.
