A BILL TO BE ENTITLED

1 AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE
2 SPECIAL NORTH CAROLINA COASTAL FEDERATION REGISTRATION
3 PLATES.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** G.S. 20-79.4(b) reads as rewritten:

7 "(b) Types. – The Division shall issue the following types of special registration
8 plates:

9 ...

10 (28c) North Carolina Coastal Federation. – Issuable to the registered owner
11 of a motor vehicle in accordance with G.S. 20-81.12. The plate shall
12 bear a phrase used by the North Carolina Coastal Federation and an
13 image that depicts the coastal area of the State. The Division may not
14 issue the plate authorized by this subdivision unless it receives at least
15 300 applications for the plate."

16 **SECTION 2.** G.S. 20-79.7(a) reads as rewritten:

17 "(a) Fees. – Upon request, the Division shall provide and issue free of charge one
18 registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled
19 veteran, and an ex-prisoner of war. All other special registration plates, including
20 additional Congressional Medal of Honor, 100% Disabled Veteran, and Ex-Prisoner of
21 War plates, are subject to the regular motor vehicle registration fee in G.S. 20-87 or
22 G.S. 20-88 plus an additional fee in the following amount:

SECTION 3. G.S. 20-79.7(b) reads as rewritten:

"(b) Distribution of Fees. – The Special Registration Plate Account and the Collegiate and Cultural Attraction Plate Account are established within the Highway Fund. The Division must credit the additional fee imposed for the special registration plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the Collegiate and Cultural Attraction Plate Account (CCAPA), and the Natural Heritage Trust Fund (NHTF), which is established under G.S. 113-77.7, as follows:

29 **SECTION 4.** G.S. 20-81.12 is amended by adding a new subsection to read:

30 "(b24) North Carolina Coastal Federation Plates. – The Division shall transfer
 31 quarterly the money in the Collegiate and Cultural Attraction Plate Account derived
 32 from the sale of North Carolina Coastal Federation Plates to the North Carolina Coastal
 33 Federation, Inc."

34 **SECTION 5.** This act is effective when it becomes law.
