A BILL TO BE ENTITLED

1 AN ACT TO APPOINT PERSONS TO VARIOUS PUBLIC OFFICES UPON THE
2 RECOMMENDATION OF THE PRESIDENT PRO TEMPORE OF THE SENATE
3 AND THE SPEAKER OF THE HOUSE OF REPRESENTATIVES.

5 Whereas, G.S. 120-121 authorizes the General Assembly to make certain
6 appointments to public offices upon the recommendation of the President Pro Tempore
7 of the Senate and the Speaker of the House of Representatives; and

8 Whereas, the President Pro Tempore of the Senate and the Speaker of the
9 House of Representatives have made recommendations; Now, therefore,
10 The General Assembly of North Carolina enacts:
