2 AN ACT TO APPOINT PERSONS TO VARIOUS PUBLIC OFFICES UPON THE
3 RECOMMENDATION OF THE PRESIDENT PRO TEMPORE OF THE SENATE
4 AND THE SPEAKER OF THE HOUSE OF REPRESENTATIVES AND TO
5 MODIFY THE MEMBERS OF THE CENTENNIAL AUTHORITY.

6 Whereas, G.S. 120-121 authorizes the General Assembly to make certain
7 appointments to public offices upon the recommendation of the President Pro Tempore
8 of the Senate and the Speaker of the House of Representatives; and

9 Whereas, the President Pro Tempore of the Senate and the Speaker of the
10 House of Representatives have made recommendations; Now, therefore,
11 The General Assembly of North Carolina enacts:

37 **SECTION 3.1.** The prefatory language of G.S. 160A-480.3(b) reads as

40 shall be chosen for terms as follows:".

41 **SECTION 3.2.** G.S. 160A-480.3(b)(1) reads as rewritten:

42 "(1) ~~Four~~Five shall be appointed by the General Assembly upon the
43 recommendation of the Speaker of the House of Representatives in
44 accordance with G.S. 120-121, at least one of whom shall be a resident

1 of the territorial jurisdiction of the authority, and at least one other of
2 whom shall have been recommended by the board of trustees of the
3 constituent institution of The University of North Carolina whose main
4 campus is located within the county;"

5 **SECTION 3.3.** G.S. 160A-480.3(b)(2) reads as rewritten:

6 "(2) ~~Four~~Five shall be appointed by the General Assembly upon the
7 recommendation of the President Pro Tempore of the Senate in
8 accordance with G.S. 120-121, at least one of whom shall be a resident
9 of the territorial jurisdiction of the authority, and at least one other of
10 whom shall have been recommended by the Board of Trustees of the
11 constituent institution of The University of North Carolina whose main
12 campus is located within the county; and".

14 **PART IV. EFFECTIVE DATE.**

15 **SECTION 4.1.** The headings to the parts and sections of this act are a
16 convenience to the reader and are for reference only.

17 **SECTION 4.2.** Except as otherwise provided in this act, this act is effective
18 when it becomes law.
