2	AN ACT ADDING A MEMBER TO THE NORTH CAROLINA BOARD OF		
3	COSMETIC ART EXAMINERS, AUTHORIZING THE NORTH CAROLINA		
4	BOARD OF COSMETIC ART EXAMINERS TO CLARIFY CERTAIN		
5	DEFINITIONS UNDER THE NORTH CAROLINA COSMETIC ART ACT, TO		
6	APPROVE EXAMINATION FACILITIES, AND TO SET LIMITS FOR FAILED		
7	CANDIDATES SEEKING TO RETAKE AN EXAMINATION, AND		
8	AMENDING CERTAIN LICENSURE REQUIREMENTS UNDER THE NORTH		
9	CAROLINA COSMETIC ART ACT.		
10	The General Assembly of North Carolina enacts:		
11	SECTION 1. G.S. 88B-3 reads as rewritten:		
12	"§ 88B-3. Creation and membership of the Board; term of office; removal for		
13	cause; officers.		
14	(a) The North Carolina Board of Cosmetic Art Examiners is established. The		
15	Board shall consist of sixseven members who shall be appointed as follows:		
16	(1) The General Assembly, upon the recommendation of the President Pro		
17	Tempore of the Senate, shall appoint a cosmetologist.		
18	(2) The General Assembly, upon the recommendation of the Speaker of		
19	the House of Representatives, shall appoint a cosmetologist.		
20	(3) The Governor shall appoint two cosmetologists, atwo cosmetology		
21	teacher, teachers, and a member of the public who is not licensed under		
22	this Chapter.		
23	(b) Each cosmetologist member shall have practiced all parts of cosmetic art in		
24	this State for at least five years immediately preceding appointment to the Board and		
25	shall not have any connection with any cosmetic art school while serving on the Board.		
26	The One of the cosmetology teacher member <u>members</u> shall be currently employed as a		
27	teacher by a North Carolina public school, community college, or other public or private

cosmetic art school and shall have practiced or taught cosmetic art for at least five years 1 immediately preceding appointment to the Board. The other cosmetology teacher 2 3 member shall be currently employed as a teacher by a North Carolina community 4 college and shall have practiced or taught cosmetic art for at least five years at a North 5 Carolina community college immediately preceding appointment to the Board. 6 (c) Cosmetologist members of the Board shall serve staggered terms of three 7 years. No Board member shall serve more than two consecutive terms, except that each 8 member shall serve until a successor is appointed and qualified. All other board 9 members shall serve three-year terms, but they shall not be staggered. 10 (d) The Governor may remove any member of the Board for cause. (e) A vacancy shall be filled in the same manner as the original appointment, 11 12 except that unexpired terms in seats appointed by the General Assembly shall be filled 13 in accordance with G.S. 120-122. Appointees to fill vacancies shall serve the remainder 14 of the unexpired term and until their successors have been duly appointed and qualified. 15 The Board shall elect a chair, a vice-chair, and other officers as deemed (f)16 necessary by the Board to carry out the purposes of this Chapter. All officers shall be 17 elected annually by the Board for one-year terms and shall serve until their successors 18 are elected and qualified. The Board shall not issue a teacher's license to any Board member during that 19 (g) 20 member's term on the Board. 21 (h) No Board member may be employed by the Board for at least one year after 22 that member's term expires." 23 SECTION 2. G.S. 88B-2 reads as rewritten: 24 "§ 88B-2. Definitions. 25 The following definitions apply in this Chapter: Apprentice. – A person who is not a manager or operator and who is 26 (1)27 engaged in learning the practice of cosmetic art under the direction and supervision of a cosmetologist. 28 29 Board. - The North Carolina Board of Cosmetic Art Examiners. (2)Booth. - A workstation located within a licensed cosmetic art shop 30 (3) that is operated primarily by one individual in performing cosmetic art 31 32 services for consumers. 33 Booth renter. – A person who rents a booth in a cosmetic art shop. (4) 34 Cosmetic art. – All or any part or combination of: (i) the systematic (5) 35 massaging with the hands or mechanical apparatus of the scalp, face, neck, shoulders, hands, and feet; (ii) the use of cosmetic chemicals and 36 preparations and antiseptics; (iii) manicuring, including the application 37 of artificial nails; (iv) esthetics; or (v) cutting, coloring, cleansing, 38 39 arranging, dressing, waving, and marcelling the hair, and the use of electricity for stimulating growth of hair.of cosmetology, esthetics, or 40 manicuring. 41 42 (6) Cosmetic art school. - Any building or part thereof where cosmetic art 43 is taught.

1	(7)	Cosmetic art shop. – Any building or part thereof where cosmetic art is
2		practiced for pay or reward, whether direct or indirect.
3	(8)	Cosmetologist. – Any individual who is licensed to practice all parts of
4		cosmetic art.
5	<u>(8a)</u>	Cosmetology The act of arranging, dressing, curling, waving,
6		cleansing, cutting, singeing, bleaching, coloring, or similar work upon
7		the hair of a person by any means, including the use of hands,
8		mechanical or electrical apparatus, or appliances or by use of cosmetic
9		or chemical preparations or antiseptics.
10	(9)	Cosmetology teacher. – An individual licensed by the Board to teach
11		all parts of cosmetic art.
12	(10)	Esthetician. – An individual licensed by the Board to practice only that
13		part of cosmetic art that constitutes skin care.
14	(11)	Esthetician teacher An individual licensed by the Board to teach
15		only that part of cosmetic art that constitutes skin care.
16	<u>(11a)</u>	Esthetics. – Refers to any of the following practices: giving facials;
17		applying makeup; performing skin care; removing superfluous hair
18		from the body of a person by use of creams, tweezers, or waxing;
19		applying eyelashes to a person, including the application of brow or
20		lash color; beautifying the face, neck, arms, or upper part of the human
21		body by use of cosmetic preparations, antiseptics, tonics, lotions, or
22		creams; surface massaging in relation to skin care; or cleaning or
23		stimulating the face, neck, ears, arms, hands, bust, torso, legs, or feet
24		of a person by means of hands, devices, apparatus, or appliances along
25		with the use of cosmetic preparations, antiseptics, tonics, lotions, or
26		<u>creams.</u>
27	(12)	Manicuring The care and treatment of the fingernails, toenails,
28		cuticles on fingernails and toenails, and the hands and feet, including
29		the decoration of the fingernails and the application of nail extensions
30		and artificial nails. The term "manicuring" shall not include the
31		treatment of pathologic conditions.
32	(13)	Manicurist. – An individual licensed by the Board to practice only that
33		part of cosmetic art that constitutes manicuring.
34	(14)	Manicurist teacher. – An individual licensed by the Board to teach
35		manicuring.
36	(15)	Shampooing. – The application and removal of commonly used, room
37		temperature, liquid hair cleaning and hair conditioning products.
38		Shampooing does not include the arranging, dressing, waving,
39		coloring, or other treatment of the hair."
40	SECT	TION 3. G.S. 88B-18 reads as rewritten:
41	"§ 88B-18. Exa	minations.
42	(a) Each	applicant for any examination shall file an application with the Board,
43	on a form appro	oved by the Board, which shall be verified by the applicant under oath,

and the applicant shall pay the required examination fee. Applications shall be filed at 1 2 least 30 days before the requested examination date. 3 Each examination shall have both a practical and a written portion. (b) Examinations for applicants for apprentice, cosmetologist, 4 (c) teacher. 5 esthetician, and manicurist licenses shall be given in at least three locations in the State 6 that are geographically scattered. The examinations shall be administered in the Board's office or in a publicly supported two-year postsecondary educational institution with 7 8 appropriate facilities. The Board shall reimburse an institution, if requested, for the use of its facilities in administering examinations. Board-approved facilities. 9 10 An applicant for a cosmetologist cosmetologist, esthetician, manicurist, or (d) teacher's license who fails to pass the examination three times may not reapply to take 11 12 the examination again until after the applicant has successfully completed any additional requirements prescribed by the Board." 13 14 **SECTION 4.** G.S. 88B-9 reads as rewritten: 15 "§ 88B-9. Qualifications for licensing as an esthetician. 16 The Board shall issue a license to practice as an esthetician to any individual who 17 meets all of the following requirements: 18 (1)Successful completion of at least 600 hours of an esthetician esthetics 19 curriculum in an approved cosmetic art school. 20 Passage of an examination conducted by the Board. (2)21 (3) Payment of the fees required by G.S. 88B-20." SECTION 5. G.S. 88B-22 reads as rewritten: 22 23 "§ 88B-22. Licenses required; criminal penalty. 24 Except as provided in this Chapter, no person may practice or attempt to (a) practice cosmetic art for pay or reward in any form, either directly or indirectly, without 25 being licensed as an apprentice, cosmetologist, esthetician, or manicurist by the Board. 26 27 Except as provided in this Chapter, no person may practice cosmetic art or (b) any part of cosmetic art, for pay or reward in any form, either directly or indirectly, 28 29 outside of a licensed cosmetic art shop. 30 No person may open or operate a cosmetic art shop in this State unless a (c) license has been issued by the Board for that shop. 31 32 An individual licensed as an esthetician or manicurist may practice only that (d) 33 part of cosmetic art for which the individual is licensed. 34 No person may teach cosmetic art in a Board-approved cosmetic art school (d1)35 unless the person is a teacher licensed under this Chapter. A guest lecturer may be exempt from the requirements of this subsection upon approval by the Board. 36 An apprentice licensed under the provisions of this Chapter shall apprentice 37 (e) 38 under the direct supervision of a cosmetologist. An apprentice shall not operate a 39 cosmetic art shop. 40 A violation of this Chapter is a Class 3 misdemeanor." (f) **SECTION 6.** G.S. 88B-21(e) reads as rewritten: 41 42 "(e) Prior to renewal of a license, a teacher, cosmetologist, esthetician, or manicurist shall annually complete eight hours of Board-approved continuing education 43 44 for each year of the licensing cycle. A cosmetologist may complete up to 24 hours of

required continuing education at any time within the cosmetologist's three-year 1 2 licensing cycle. Licensees shall submit written documentation to the Board showing that 3 they have satisfied the requirements of this subsection. A licensee who is in active 4 practice as a cosmetologist, esthetician, or manicurist, has practiced for at least 10 5 consecutive years in that profession and is 60 years of age or older does not have to 6 meet the continuing education requirements of this subsection. A licensee who is in 7 active practice as a cosmetologist and, as of October 1, 2004, has at least 20 consecutive 8 years of experience as a cosmetologist, does not have to meet the continuing education 9 requirements of this subsection, but shall report any continuing education classes 10 completed to the Board, whether the continuing education classes are Board-approved or not. Promotion of products and systems shall be allowed at continuing education 11 12 given in-house or at trade shows. Continuing education classes may also be offered in secondary languages as needed. No member of the Board may offer continuing 13 14 education courses as required by this section."
