| 12 | (b2) The Commissioner shall deny any license under this Article if the applicant has               |
| 13 | been convicted of a misdemeanor drug violation under Article 5 of Chapter 90 of the General        |
| 14 | Statutes within the previous 24 months of the date of the application for the license."            |
