1 A BILL TO BE ENTITLED 2 AN ACT TO EXERCISE THE POWER OF THE GENERAL ASSEMBLY UNDER 3 SECTION 1 OF ARTICLE VII OF THE NORTH CAROLINA CONSTITUTION TO FIX 4 THE BOUNDARIES OF CITIES AND GIVE SUCH POWERS TO CITIES AS IT 5 DEEMS ADVISABLE BY DEANNEXING SPECIFIED LOCAL INVOLUNTARY 6 **SPECIFIED** ANNEXATION AREAS. BY REPEALING **INVOLUNTARY** 7 ANNEXATION ORDINANCES, AND BY PROHIBITING MUNICIPAL INITIATION 8 OF ANY PROCEDURE TO INVOLUNTARILY ANNEX THOSE AREAS FOR 9 TWELVE YEARS. 10 The General Assembly of North Carolina enacts: SECTION 1. Deannexation. - Any area affected by an annexation ordinance 11 described in Section 4 of this act that is part of the corporate limits of a municipality on the 12 effective date of this act is hereby removed from that municipality's corporate limits on the 13 effective date of this act. The operation and enforcement of any annexation ordinance described 14 15 in Section 4 of this act that is pending on the effective date of this act is suspended on and after the effective date of this act. 16 17 **SECTION 2.** Repeal annexation ordinances. – All annexation ordinances described 18 in Section 4 of this act are repealed as of the effective date of this act. 19 SECTION 3. Twelve-year prohibition on involuntary annexation. - All areas affected by the annexation ordinances described in Section 4 of this act shall not be subject to 20 21 any annexation proceeding, other than a voluntary annexation under Part 1 or Part 4 of Article 22 4A of Chapter 160A of the General Statutes, or local act of the General Assembly, for a period of 12 years from and after the effective date of this act. After the 12-year period, the area may 23 24 be subject to annexation in accordance with State law effective at that time. 25 **SECTION 4.** Repealed involuntary annexation ordinances. – 26 (1)Kinston annexation ordinance, as described in House Bill 5, First Edition, 27 2011 Regular Session. 28 Lexington annexation ordinance, as described in House Bill 37, First (2)29 Edition, 2011 Regular Session.
