A BILL TO BE ENTITLED

- AN ACT TO TRANSFER THE ADMINISTRATION OF THE STATE APPRENTICESHIP
 PROGRAM FROM THE DEPARTMENT OF COMMERCE TO THE COMMUNITY
 COLLEGES SYSTEM OFFICE.
- 5 The General Assembly of North Carolina enacts:

6 All functions, powers, duties, obligations, resources, and SECTION 1. 7 appropriations vested in the Apprenticeship Program and the Apprenticeship Council are 8 transferred to, vested in, and consolidated into the North Carolina Community Colleges System 9 Office as a Type I transfer, as defined in G.S. 143A-6. The State Board of Community Colleges, the Community Colleges System Office, and the Office of State Budget and 10 Management are authorized to take all other steps necessary to consolidate the Apprenticeship 11 12 Program and the Apprenticeship Council into the Community Colleges System Office. Joint delivery of Apprenticeship and Community College workforce training programs shall ensure 13 14 coordination of program delivery and appropriate classroom training supporting the needs of 15 students and employers.

SECTION 3. Chapter 94 of the General Statutes reads as rewritten:

"Chapter 94.

"Apprenticeship.<u>ApprenticeshipNC.</u>

SECTION 2. Article 1 of Chapter 115D is amended by adding a new section to

"§ 94-1. Purpose.

26 The purposes of this Chapter are: to open to young people the opportunity to obtain training 27 that will equip them for profitable employment and citizenship; to set up, as a means to this 28 end, a program of voluntary apprenticeship under approved apprentice agreements providing 29 facilities for their training and guidance in the arts and crafts of industry and trade, with parallel 30 instruction in related and supplementary education; to promote employment opportunities for 31 young people under conditions providing adequate training and reasonable earnings; to relate 32 the supply of skilled workers to employment demands; to establish standards for apprentice training; to coordinate workforce education and customized training tools to fill talent pipeline 33 34 gaps, as appropriate, with local business and industry; to establish an Apprenticeship Council and apprenticeship committees and sponsors to assist in effectuating the purposes of this 35

1 Chapter; to leverage the collaborative and regional structure of the community college service 2 areas with the Collaboration for Prosperity Zones set out in G.S. 143B-28.1; to provide for a 3 Director of ApprenticeshipApprenticeshipNC within the Department of Commerce; Community 4 Colleges System Office; to provide for reports to the legislature and to the public regarding the 5 status of apprentice training in the State; to establish a procedure for the determination of 6 apprentice agreement controversies; and to accomplish related ends. 7 "§ 94-2. Apprenticeship Council. 8 The Secretary of CommerceState Board of Community Colleges shall appoint an 9 Apprenticeship Council composed of four representatives each from employer and employee 10 organizations respectively and three representatives from the public at large. One State official 11 designated by the Department of Public Instruction and one State official designated by the 12 Department of Community CollegesCommerce shall be a member ex officio of said council, 13 without vote. The terms of office of the members of the Apprenticeship Council first appointed 14 by the Secretary of CommerceState Board of Community Colleges shall expire as designated by the SecretaryState Board at the time of making the appointment: twothree representatives 15 16 each of employers and employees, being appointed for one year and one representativetwo 17 representatives of the public at large being appointed for two years; and one representative each 18 of employers, employees, and the public at large being appointed for a term of three 19 years.large. Any member appointed to fill a vacancy occurring prior to the expiration of the 20 term of his or her predecessor shall be appointed for the remainder of said term. Each member 21 of the Council not otherwise compensated by public moneys, shall be reimbursed for 22 transportation and shall receive such per diem compensation as is provided generally for boards 23 and commissions under the biennial maintenance appropriation acts for each day spent in 24 attendance at meetings of the Apprenticeship Council. The Secretary of CommerceState Board 25 of Community Colleges shall annually appoint one member of the Council to act as its

26 chairman.

27 The Apprenticeship Council shall meet at the call of the Secretary of CommerceState Board 28 of Community Colleges and shall aid himthe State Board and the Community Colleges System 29 Office in formulating policies for the effective administration of this Chapter. Subject to the 30 approval of the Secretary, State Board of Community Colleges, the Apprenticeship Council 31 shall establish standards for apprentice agreement which in no case shall be lower than those 32 prescribed by this Chapter, shall issue such rules and regulations as may be necessary to carry 33 out the intent and purposes of said Chapter, and shall perform such other functions as the 34 SecretaryState Board of Community Colleges may direct. Not less than once a year the 35 Apprenticeship Council shall make a report through the SecretaryCommunity Colleges System 36 Office of its activities and findings to the legislature and to the public.

37 "§ 94-3. Director of Apprenticeship. <u>ApprenticeshipNC.</u>

38 The Secretary of CommerceState Board of Community Colleges is hereby directed to 39 appoint a Director of ApprenticeshipApprenticeshipNC which appointment shall be subject to 40 the confirmation of the State Apprenticeship Council by a majority vote. The Secretary of 41 Commerce The Director shall report to the Vice President of Economic Development and the 42 Vice President of Academic Programs and Student Services within the Community Colleges System Office. Upon the recommendation of the Director, the State Board of Community 43 Colleges is further authorized to appoint and employ such clerical, technical, and professional 44 help as shall be necessary to effectuate the purposes of this Chapter. The Director shall 45 supervise clerical, technical, and professional staff appointed to administer the 46 47 ApprenticeshipNC program.

48 "§ 94-4. Powers and duties of Director of Apprenticeship.<u>ApprenticeshipNC.</u>

49 The Director, under the supervision of the <u>Secretary of CommerceVice President of</u> 50 Economic Development and with the advice and guidance of the Apprenticeship Council is

51 authorized to administer the provisions of this Chapter; in cooperation with the Apprenticeship

1 Council and apprenticeship committees and sponsors, to set up conditions and training 2 standards for apprentice agreements, which conditions or standards shall in no case be lower 3 than those prescribed by this Chapter; to act as secretary of the Apprenticeship Council; to 4 approve for the Council if in his or her opinion approval is for the best interest of the 5 apprenticeship any apprentice agreement which meets the standards established under this 6 Chapter; to terminate or cancel any apprentice agreement in accordance with the provisions of 7 such agreement; to keep a record of apprentice agreements and their disposition; to issue 8 certificates of completion of apprenticeship; and to perform such other duties as are necessary 9 to carry out the intent of this Chapter, including other on-job training necessary for emergency 10 and critical civilian production: Provided, that the administration and supervision of related and 11 supplemental instruction for apprentices, coordination of instruction with job experiences, and the selection and training of teachers and coordinators for such instruction shall be the 12 13 responsibility of State and local boards responsible for vocational education.

14 "§ 94-5. Apprenticeship committees and program sponsors.

(a) As used in this Chapter:

- (1) "Apprenticeship program" means a plan containing all terms and conditions for the qualification, recruitment, selection, employment, and training of apprentices, including such matters as the requirement for a written apprenticeship agreement.
- (2) "Apprenticeship agreement" means a written agreement between an apprentice and either his <u>or her</u> employer or an apprenticeship committee or sponsor acting as agent for employer(s), which agreement satisfies the requirements of G.S. 94-7.
 - (2a) <u>"ApprenticeshipNC" means the statewide apprenticeship program</u> administered by the Community Colleges System Office under this Chapter.
 - (3) "Sponsor" means any person, firm, corporation, organization, association or committee operating an apprenticeship program and in whose name the apprenticeship program is approved.
 - (4) "Employer" means any person, firm, corporation or organization employing an apprentice whether or not such person, firm, corporation or organization is a party to an apprenticeship agreement with the apprentice.
- 32 "Apprenticeship committee" means those persons designated by the sponsor, (5) 33 and approved by the Apprenticeship Council, to act for it in the 34 administration of the apprenticeship program. A committee may be "joint," 35 i.e., it is composed of an equal number of representatives of the employer(s) 36 and of the employees represented by a bona fide collective bargaining 37 agent(s) and has been established to conduct, operate or administer an 38 apprenticeship program and enter into apprenticeship agreements with 39 apprentices. A committee may be "unilateral" or "nonjoint" which shall 40 mean a program sponsor in which employees or a bona fide collective 41 bargaining agent is not a party.
- 42 (b) An apprenticeship committee may be appointed by the Apprenticeship Council in
 43 any trade or group of trades in a city or trade area, whenever the apprentice training needs of
 44 such trade or group of trades justifies such establishment.

45 (c) The function of the apprenticeship committee, or sponsor when there is no 46 apprenticeship committee, shall be: to cooperate with school authorities in regard to the 47 education of apprentices; in accordance with the standards set up by the apprenticeship 48 committee for the same trade or group of trades, where such committee has been appointed, to 49 work in an advisory capacity with employers and employees in matters regarding schedule of 50 operations, application of wage rates, and working conditions for apprentices and to specify the 51 number of apprentices which shall be employed locally in the trade under the apprenticeship

1 agreements under this Chapter; and to adjust apprenticeship disputes, subject to the approval of 2 the director; to ascertain the prevailing rate for journeymen in the city or trade area and specify 3 the graduated scale of wages applicable to apprentices in such trade in such area; to ascertain 4 employment needs in such trade or group of trades and specify the appropriate current ratio of 5 apprentices to journeymen; and to make recommendations for the general good of apprentices engaged in the trade or trades represented by the committee. An apprenticeship committee may 6 7 appoint a representative and delegate to such representative the authority for implementation 8 and performance of any standards adopted by the committee pursuant to any of the 9 aforementioned functions.

10 "§ 94-6. Definition of an apprentice.

11 The term "apprentice," as used herein, shall mean a person at least 16 years of age who is 12 covered by a written apprenticeship agreement approved by the Apprenticeship Council, which 13 apprenticeship agreement provides for not less than 2,000 hours of reasonably continuous 14 employment for such person for his participation in an approved schedule of work experience 15 and for organized, related supplemental instruction in technical subjects related to the trade. A 16 minimum of 144 hours of related supplemental instruction for each year of apprenticeship is 17 recommended. The required hours for apprenticeship agreements and the recommended hours 18 for related supplemental instruction may be decreased or increased in accordance with 19 standards adopted by the apprenticeship committee or sponsor, subject to approval of the 20 Secretary of Commerce. State Board of Community Colleges.

22 "§ 94-9. Rotation of employment.

23 For the purpose of providing greater diversity of training or continuity of employment, any 24 apprentice agreement made under this Chapter may in the discretion of the Director of 25 ApprenticeshipApprenticeshipNC be signed by an association of employers or an organization 26 of employees instead of by an individual employer. In such a case, the apprentice agreement 27 shall expressly provide that the association of employers or organization of employees does not 28 assume the obligation of an employer but agrees to use its best endeavors to procure 29 employment and training for such apprentice with one or more employers who will accept full 30 responsibility, as herein provided, for all the terms and conditions of employment and training 31 set forth in said agreement between the apprentice and employer association or employee 32 organization during the period of each such employment. The apprentice agreement in such a 33 case shall also expressly provide for the transfer of the apprentice, subject to the approval of the 34 Director, to such employer or employers who shall sign in written agreement with the 35 apprentice, and if the apprentice is a minor with his or her parent or guardian, as specified in 36 G.S. 94-8, contracting to employ said apprentice for the whole or a definite part of the total 37 period of apprenticeship under the terms and conditions of employment and training set forth in 38 the said agreement entered into between the apprentice and employer association or employee 39 organization.

41 "**§ 94-11. Limitation.**

42 Nothing in this Chapter or in any apprentice agreement approved under this Chapter shall 43 operate to invalidate any apprenticeship provision in any collective agreement between 44 employers and employees, setting up higher apprenticeship standards; provided, that none of 45 the terms or provisions of this Chapter shall apply to any person, firm, corporation or crafts 46 unless, until, and only so long as such person, firm, corporation or crafts voluntarily elects that 47 the terms and provisions of this Chapter shall apply. Any person, firm, corporation or crafts 48 apprenticeship terminating an agreement shall notify the Director of 49 Apprenticeship. ApprenticeshipNC.

50 "§ 94-12. Repealed by Session Laws 2015-241, s. 15.13, effective July 1, 2015."

SECTION 4. Notwithstanding G.S. 94-2, as amended by this act, the current members serving on the Apprenticeship Council as of July 1, 2017, shall serve the remainder of their terms. Thereafter, as terms expire, or when a vacancy occurs prior to the expiration of a term, members on the Apprenticeship Council shall be appointed by the State Board of Community Colleges in accordance with G.S. 94-2, as amended by this act.

6 **SECTION 5.** Of the Workforce Investment Act funds awarded to the Department 7 of Commerce by the United States Department of Labor, the sum of three hundred fifty 8 thousand dollars (\$350,000) shall be transferred to the Community Colleges System Office for 9 the administration of ApprenticeshipNC on a recurring basis for the 2017-2019 fiscal biennium.

10 **SECTION 6.** There is appropriated from the General Fund to the Community 11 Colleges System Office the sum of five hundred thousand dollars (\$500,000) in recurring funds 12 for the 2017-2018 fiscal year to increase apprenticeship opportunities across the State.

13 **SECTION 7.** The Department of Commerce shall submit a Workforce Innovation 14 and Opportunity Act State Plan amendment to the United States Department of Labor to 15 designate the Community Colleges System Office as the State agency responsible for the 16 administration of ApprenticeshipNC as provided for in this act.

SECTION 8. Sections 1 through 6 of this act become effective July 1, 2017. The
 remainder of this act is effective when it becomes law.
