2 AN ACT TO IMPLEMENT THE CONSTITUTIONAL AMENDMENT REQUIRING
3 PHOTOGRAPHIC IDENTIFICATION TO VOTE.

4 The General Assembly of North Carolina enacts:

6 **PART I: IMPLEMENTATION OF THE CONSTITUTIONAL REQUIREMENT**
7 **REQUIRING PHOTOGRAPHIC IDENTIFICATION TO VOTE**

8 **SECTION 1.1.(a)** Article 17 of Chapter 163A of the General Statutes is amended by
9 adding a new section to read:

10 **"§ 163A-869.1. Voter photo identification cards.**

11 (a) The county board of elections shall, in accordance with this section, issue without
12 charge voter photo identification cards upon request to registered voters. The voter photo
13 identification cards shall contain a photograph of the registered voter, the name of the registered
14 voter, and the voter registration number for that registered voter. The voter photo identification
15 card shall be used for voting purposes only and shall expire 10 years from the date of issuance.
16 The expiration of a voter photo identification card shall not create a presumption that the voter's
17 voter registration has expired or become inactive, and a voter's voter registration shall not be
18 rendered inactive solely due to the expiration of the voter photo identification card.

19 (b) The State Board shall make available to county boards of elections the equipment
20 necessary to print voter photo identification cards. County boards of elections shall operate and
21 maintain the equipment necessary to print voter photo identification cards.

22 (c) County boards of elections shall maintain a secure database containing the
23 photographs of registered voters taken for the purpose of issuing voter photo identification cards.

24 (d) The State Board shall adopt rules to ensure at a minimum, but not limited to, the
25 following:

26 (1) A registered voter seeking to obtain a voter photo identification card shall
27 provide the registered voter's name, the registered voter's date of birth, and the
28 last four digits of the voter's social security number.

29 (2) Voter photo identification cards shall be issued at any time, except during the
30 time period between the end of one-stop voting for a primary or election as
31 provided in G.S. 163A-1300 and election day for each primary and election.



- 1 (3) If the registered voter loses or defaces the voter's photo identification card, the
2 registered voter may obtain a duplicate card without charge from his or her
3 county board of elections upon request in person, or by telephone or mail.
4 (4) If a registered voter has a change of name and has updated his or her voter
5 registration to reflect the new name, the registered voter may request and
6 obtain a replacement card from the registered voter's county board of elections
7 by providing the registered voter's date of birth and the last four digits of the
8 registered voter's social security number in person, by telephone, or by mail.
9 (5) Voter photo identification cards issued must contain the following disclaimer:
10 "Expiration of this voter photo identification card does not automatically
11 result in the voter's voter registration becoming inactive."

12 (e) Ninety days prior to expiration, the county board of elections shall notify any
13 registered voter issued a voter photographic identification card under this section of the
14 impending expiration of the voter photographic identification card."

15 **SECTION 1.1.(b)** Voter photo identification cards, as required by G.S 163A-869.1,
16 as enacted by this act, shall be available on request no later than May 1, 2019. The State Board
17 shall adopt temporary rules to implement G.S. 163A-869.1, as enacted by this act, no later than
18 April 15, 2019.

19 **SECTION 1.2.(a)** Article 20 of Chapter 163A of the General Statutes is amended by
20 adding a new section to read:

21 **§ 163A-1145.1. Requirement for photo identification to vote in person.**

22 (a) Photo Identification Required to Vote. – When a registered voter presents to vote in
23 person, the registered voter shall produce any of the following forms of identification that contain
24 a photograph of the registered voter:

- 25 (1) Any of the following that is valid and unexpired, or has been expired for one
26 year or less:
27 a. A North Carolina drivers license.
28 b. A special identification card for nonoperators issued under
29 G.S. 20-37.7 or other form of nontemporary identification issued by
30 the Division of Motor Vehicles of the Department of Transportation.
31 c. A United States passport.
32 d. A North Carolina voter photo identification card of the registered voter
33 issued pursuant to G.S. 163A-869.1.
34 e. A tribal enrollment card issued by a State or federal recognized tribe.
35 g. A student identification card issued by a constituent institution of The
36 University of North Carolina, a community college, as defined in
37 G.S. 115D-2(2), or eligible private postsecondary institution as
38 defined in G.S. 116-280(3), provided that card is issued in accordance
39 with G.S. 163A-1145.2.
40 h. An employee identification card issued by a state or local government
41 entity, including a charter school, provided that card is issued in
42 accordance with G.S. 163A-1145.3.
43 i. A drivers license or special identification card for nonoperators issued
44 by another state, the District of Columbia, or a territory or
45 commonwealth of the United States, but only if the voter's voter
46 registration was within 90 days of the election.
47 (2) Any of the following, regardless of whether the identification contains a
48 printed expiration or issuance date:
49 a. A military identification card issued by the United States government.

1 b. A Veterans Identification Card issued by the United States Department
2 of Veterans Affairs for use at Veterans Administration medical
3 facilities.

4 (3) Any expired form of identification allowed in this subsection presented by a
5 registered voter having attained the age of 65 years at the time of presentation
6 at the voting place, provided that the identification was unexpired on the
7 registered voter's sixty-fifth birthday.

8 (b) Verification of Photo Identification. – After presentation of the required identification
9 described in subsection (a) of this section, the precinct officials assigned to check registration
10 shall compare the photograph contained on the required identification with the person presenting
11 to vote. The precinct official shall verify that the photograph is that of the person seeking to vote.
12 If the precinct official disputes that the photograph contained on the required identification is the
13 person presenting to vote, a challenge shall be conducted in accordance with the procedures of
14 G.S. 163A-914. A voter shall be permitted to vote unless the judges of election present
15 unanimously agree that the photo identification presented does not bear a reasonable resemblance
16 to that voter.

17 (c) Provisional Ballot Required Without Photo Identification. – If the registered voter
18 cannot produce the identification as required in subsection (a) of this section, the registered voter
19 may cast a provisional ballot that is counted only if the registered voter brings an acceptable form
20 of photograph identification listed in subsection (a) of this section to the county board of elections
21 no later than the end of business on the business day prior to the canvass by the county board of
22 elections as provided in G.S. 163A-1172. The State Board shall provide the registered voter
23 casting a provisional ballot due to failure to provide photo identification an information sheet on
24 the deadline to return to the county board of elections to present photo identification, and what
25 forms of photo identification are acceptable, in order for the voter's provisional ballot to be
26 counted.

27 (d) Exceptions. – The following exceptions are provided for a registered voter who does
28 not produce an acceptable form of identification as required in subsection (a):

29 (1) Religious Objection. – If a registered voter does not produce an acceptable
30 form of photograph identification due to a religious objection to being
31 photographed, the registered voter may complete an affidavit under penalty of
32 perjury at the voting place and affirm that the registered voter: (i) is the same
33 individual who personally appears at the voting place; (ii) will cast the
34 provisional ballot while voting in person; and (iii) has a religious objection to
35 being photographed. Upon completion of the affidavit, the registered voter
36 may cast a provisional ballot.

37 (2) Reasonable Impediment. – If a registered voter does not produce an acceptable
38 form of photograph identification because the registered voter suffers from a
39 reasonable impediment that prevents the registered voter from presenting
40 photograph identification, the registered voter may complete an affidavit
41 under the penalty of perjury at the voting place and affirm that the registered
42 voter: (i) is the same individual who personally appears at the voting place;
43 (ii) will cast the provisional ballot while voting in person; and (iii) suffers
44 from a reasonable impediment that prevents the registered voter from
45 presenting photograph identification. The registered voter also shall complete
46 a reasonable impediment declaration form provided in subsection (d1) of this
47 section, unless otherwise prohibited by state or federal law. Upon completion
48 of the affidavit, the registered voter may cast a provisional ballot.

49 (3) Natural Disaster. – If a registered voter does not produce an acceptable form
50 of photograph identification due to being a victim of a natural disaster
51 occurring within 100 days before election day that resulted in a disaster

1 declaration by the President of the United States or the Governor of this State,
2 the registered voter may complete an affidavit under penalty of perjury at the
3 voting place and affirm that the registered voter: (i) is the same individual who
4 personally appears at the voting place; (ii) will cast the provisional ballot
5 while voting in person; and (iii) was a victim of a natural disaster occurring
6 within 100 days before election day that resulted in a disaster declaration by
7 the President of the United States or the Governor of this State. Upon
8 completion of the affidavit, the registered voter may cast a provisional ballot.

9 (d1) Reasonable Impediment Declaration Form. – The State Board shall adopt a
10 reasonable impediment declaration form that, at a minimum, includes the following as separate
11 boxes that a registered voter may check to identify the registered voter's reasonable impediment:

12 (1) Inability to obtain photo identification due to:

13 a. Lack of transportation.

14 b. Disability or illness.

15 c. Lack of birth certificate or other underlying documents required.

16 d. Work schedule.

17 e. Family responsibilities.

18 (2) Lost or stolen photo identification.

19 (3) Photo identification applied for but not yet received by the registered voter
20 voting in person.

21 (4) Other reasonable impediment. If the registered voter checks the "other
22 reasonable impediment" box, a further brief written identification of the
23 reasonable impediment shall be required, including the option to indicate that
24 State or federal law prohibits listing the impediment.

25 (e) County Board Review of Exceptions. – If the county board of elections determines
26 that the registered voter voted a provisional ballot only due to the inability to provide proof of
27 identification and the required affidavit required in subsection (d) of this section is submitted, the
28 county board of elections shall find that the provisional ballot is valid unless the county board
29 has grounds to believe the affidavit is false.

30 (f) Purpose. – The purpose of the identification required pursuant to subsection (a) of this
31 section is to confirm the person presenting to vote is the registered voter on the voter registration
32 records. Any address listed on the identification is not determinative of a registered voter's
33 residence for the purpose of voting. A registered voter's residence for the purpose of voting is
34 determined pursuant to G.S. 163A-842."

35 **SECTION 1.2.(b)** Article 20 of Chapter 163A of the General Statutes is amended
36 by adding a new section to read:

37 **"§ 163A-1145.2. Approval of student identification cards for voting identification.**

38 (a) The State Board shall approve the use of student identification cards issued by a
39 constituent institution of The University of North Carolina, a community college, as defined in
40 G.S. 115D-2(2), or eligible private postsecondary institution as defined in G.S. 116-280(3) for
41 voting identification under G.S. 163A-1145.1 if the following criteria are met:

42 (1) The chancellor, president, or registrar of the university or college submits a
43 signed letter to the Executive Director of the State Board under penalty of
44 perjury that the following are true:

45 a. The identification cards that are issued by the university or college
46 contain photographs of students taken by the university or college or
47 its agents or contractors.

48 b. The identification cards are issued after an enrollment process that
49 includes methods of confirming the identity of the student that include,
50 but are not limited to, the social security number, citizenship status,
51 and birthdate of the student.

1 c. The equipment for producing the identification cards is kept in a secure
2 location.
3 d. Misuse of the equipment for producing the identification cards would
4 be grounds for student discipline or termination of an employee.
5 e. University or college officials would report any misuse of student
6 identification card equipment to law enforcement if
7 G.S. 163A-1389(19) was potentially violated.
8 f. The cards issued by the university or college contain a date of
9 expiration, effective January 1, 2021.
10 g. The university or college provides copies of standard identification
11 cards to the State Board to assist with training purposes.
12 h. The college or university will provide a copy to students, when issuing
13 the student identification card, of the documentation developed by the
14 State Board on the requirements related to identification for voting;
15 the requirements to vote absentee, early, or on election day; a
16 description of voting by provisional ballot; and the availability of a
17 free North Carolina voter photo identification card pursuant to G.S.
18 163A-869.1 to rural, military, veteran, elderly, underserved, minority,
19 or other communities as determined by local needs; and the
20 requirements of North Carolina residency to vote, including applicable
21 intent requirements of North Carolina law, and the penalty for voting
22 in multiple states.

23 (2) The university or college complies with any other reasonable security
24 measures determined by the State Board to be necessary for the protection and
25 security of the student identification process.

26 (b) The State Board shall approve the use of student identification cards issued by a
27 constituent institution of The University of North Carolina, a community college, as defined in
28 G.S. 115D-2(2), or eligible private postsecondary institution as defined in G.S. 116-280(3) every
29 four years.

30 (c) The State Board shall produce a list of participating universities and colleges every
31 four years. The list shall be published on the State Board's Web site and distributed to every
32 county board of elections.

33 (d) If a participating college or university with a student identification card approved for
34 use by the State Board as provided in subsection (b) of this section changes the design of the
35 student identification card, that college or university shall provide copies of the new design of
36 the student identification cards to the State Board to assist with training purposes."

37 **SECTION 1.2.(c)** Article 20 of Chapter 163A of the General Statutes is amended by
38 adding a new section to read:

39 "**§ 163A-1145.3. Approval of employee identification cards for voting identification.**

40 (a) The State Board shall approve the use of employee identification card issued by a
41 state or local government entity, including a charter school, for voting identification under
42 G.S. 163A-1145.1 if the following criteria are met:

43 (1) The head elected official or lead human resources employee of the state or
44 local government entity or charter school submits a signed letter to the
45 Executive Director of the State Board under penalty of perjury that the
46 following are true:

47 a. The identification cards that are issued by the state or local government
48 entity contain photographs of the employees taken by the employing
49 entity or its agents or contractors.

50 b. The identification cards are issued after an employment application
51 process that includes methods of confirming the identity of the

employee that include, but are not limited to, the social security number, citizenship status, and birthdate of the employee.

c. The equipment for producing the identification cards is kept in a secure location.

d. Misuse of the equipment for producing the identification cards would be grounds for termination of an employee.

e. State or local officials would report any misuse of identification card equipment to law enforcement if G.S. 163A-1389(19) was potentially violated.

f. The cards issued by the state or local government entity contain a date of expiration, effective January 1, 2021.

g. The state or local government entity provides copies of standard identification cards to the State Board to assist with training purposes.

(2) The state or local government entity complies with any other reasonable security measures determined by the State Board to be necessary for the protection and security of the employee identification process.

(b) The State Board shall approve the use of employee identification cards issued by a state or local government entity, including a charter school, for voting identification under G.S. 163A-1145.1 every four years.

(c) The State Board shall produce a list of participating employing entities every four years. The list shall be published on the State Board's Web site and distributed to every county board of elections."

SECTION 1.2.(d) G.S. 163A-1307 reads as rewritten:

"§ 163A-1307. Absentee ballots, applications on container-return envelopes, and instruction sheets.

(a) Absentee Ballot Form. – In accordance with the provisions of G.S. 163A-1308, persons entitled to vote by absentee ballot shall be furnished with official ballots.

(b) Application on Container-Return Envelope. – In time for use not later than 60 days before a statewide general election in an even-numbered year, and not later than 50 days before a statewide primary, other general election or county bond election, the county board of elections shall print a sufficient number of envelopes in which persons casting absentee ballots may transmit their marked ballots to the county board of elections. However, in the case of municipal elections, sufficient container-return envelopes shall be made available no later than 30 days before an election. Each container-return envelope shall have printed on it an application which shall be designed and prescribed by the State Board, providing for all of the following:

(1) The voter's certification of eligibility to vote the enclosed ballot and of having voted the enclosed ballot in accordance with this Part.

(2) A space for identification of the envelope with the voter and the voter's signature.

(3) A space for the identification of the two persons witnessing the casting of the absentee ballot in accordance with G.S. 163A-1310, those persons' signatures, and those persons' addresses.

(4) A space for the name and address of any person who, as permitted under G.S. 163A-1298(a), assisted the voter if the voter is unable to complete and sign the certification and that individual's signature.

(5) A space for approval by the county board of elections.

(6) A space to allow reporting of a change of name as provided by G.S. 163A-880.

(7) A prominent display of the unlawful acts under G.S. 163A-1298 and G.S. 163A-1389, except if there is not room on the envelope, the State Board may provide for that disclosure to be made on a separate piece of paper to be included along with the container-return envelope.

- 1 (8) An area to attach additional documentation necessary to comply with the
2 identification requirements in accordance with State Board rules, as provided
3 in G.S. 163A-1309.

4 The container-return envelope shall be printed in accordance with the instructions of the State
5 Board.

6 (c) Instruction Sheets. – In time for use not later than 60 days before a statewide general
7 election in an even-numbered year, and not later than 50 days before a statewide primary, other
8 general or county bond election, the county board of elections shall prepare and print a sufficient
9 number of sheets of instructions on how voters are to prepare absentee ballots and return them to
10 the county board of elections. However, in the case of municipal elections, instruction sheets
11 shall be made available no later than 30 days before an election."

12 **SECTION 1.2.(e)** G.S. 163A-1309 reads as rewritten:

13 "**§ 163A-1309. Method of requesting absentee ballots.**

14 (a) Valid Types of Written Requests. – A completed written request form for an absentee
15 ballot as required by G.S. 163A-1308 is valid only if it is on a form created by the State Board
16 and signed by the voter requesting absentee ballots or that voter's near relative or verifiable legal
17 guardian. The State Board shall make the form available at its offices, online, and in each county
18 board of elections office, and that form may be reproduced. A voter may make a request in person
19 or by writing to the county board for the form to request an absentee ballot. The request form for
20 an absentee ballot shall require at least the following information:

- 21 (1) The name and address of the residence of the voter.
22 (2) The name and address of the voter's near relative or verifiable legal guardian
23 if that individual is making the request.
24 (3) The address of the voter to which the application and absentee ballots are to
25 be mailed if different from the residence address of the voter.
26 (4) ~~One or more of the following in the order of preference:~~
27 a. ~~The number of the voter's North Carolina drivers license issued under~~
28 ~~Article 2 of Chapter 20 of the General Statutes, including a learner's~~
29 ~~permit or a provisional license.~~
30 b. ~~The number of the voter's special identification card for nonoperators~~
31 ~~issued under G.S. 20-37.7.~~
32 c. ~~The last four digits of the applicant's social security number.~~
33 The identification required in accordance with State Board rules, as provided
34 in subsection (f) of this section.
35 (5) The voter's date of birth.
36 (6) The signature of the voter or of the voter's near relative or verifiable legal
37 guardian if that individual is making the request.

38 (b) A completed request form for an absentee ballot shall be deemed a request to update
39 the official record of voter registration for that voter and shall be confirmed in writing in
40 accordance with G.S. 163A-877(d).

41 (c) The completed request form for an absentee ballot shall be delivered to the county
42 board of elections. If the voter does not include the information requested in subdivision (a)(4)
43 of this section, a copy of a document listed in G.S. 163A-1144(a)(2) shall accompany the
44 completed request form.

45 (d) Upon receiving a completed request form for an absentee ballot, the county board
46 shall confirm that voter's registration. If that voter is confirmed as a registered voter of the county,
47 the absentee ballots and certification form shall be mailed to the voter, unless personally
48 delivered in accordance with G.S. 163A-1308(b). If the voter's official record of voter
49 registration conflicts with the completed request form for an absentee ballot or cannot be
50 confirmed, the voter shall be so notified. If the county board cannot resolve the differences, no
51 application or absentee ballots shall be issued.

1 (e) Invalid Types of Written Requests. – A request is not valid if it does not comply with
2 subsection (a) of this section. If a county board of elections receives a request for an absentee
3 ballot that does not comply with subsection (a) of this section, the board shall not issue an
4 application and ballot under G.S. 163A-1308.

5 (f) Rules by State Board. – The State Board shall adopt rules for the enforcement of this
6 ~~section~~ section, including rules to provide for the forms of identification that must be included
7 with the written request for an absentee ballot. At a minimum, the rules shall include the
8 following:

9 (1) Acceptable forms of readable identification that are substantially similar to
10 those required under G.S. 163A-1145.1.

11 (2) A process for a voter without acceptable readable identification under
12 subdivision (1) of this section to complete an alternative affidavit in
13 accordance with G.S. 163A-1145.1(d)(1), (d)(2), or (d)(3) that includes lack
14 of access to a method to attach an electronic or physical copy of the
15 identification card to the written request as a reasonable impediment to
16 compliance with the identification requirement.

17 (3) A process for a voter to request the option to return the information required
18 by subdivision (1) or (2) of this section with the absentee ballot
19 container-return envelope, as provided in G.S. 163A-1307."

20 **SECTION 1.2.(f)** Notwithstanding G.S. 163A-1145.1, 163A-1145.2, and
21 163A-1145.3, the State Board shall approve (i) tribal enrollment cards issued by a tribe
22 recognized by this State under Chapter 71A of the General Statutes; (ii) student identification
23 cards issued by a constituent institution of The University of North Carolina, a community
24 college, as defined in G.S. 115D-2(2), or eligible private postsecondary institution as defined in
25 G.S. 116-280(3); and (iii) employee identification cards issued by a state or local government
26 entity, including a charter school, for use as voting identification under G.S. 163A-1145.1 no
27 later than March 15, 2019, for use in primaries and elections held in 2019 and 2020, and again
28 no later than May 15, 2021, for elections held on or after that date. The State Board shall adopt
29 temporary rules on reasonable security measures for use of student or employee identification
30 cards for voting identification in G.S. 163A-1145.2 and G.S. 163A-1145.3 no later than February
31 1, 2019. The State Board shall adopt permanent rules on reasonable security measures for use of
32 student or employee identification cards for voting identification in G.S. 163A-1145.2 and
33 G.S. 163A-1145.3 no later than May 15, 2021. The State Board shall produce the initial list of
34 participating institutions and employing entities no later than April 1, 2019.

35 **SECTION 1.2.(g)** Notwithstanding G.S. 163A-1145.1, 163A-1145.2, and
36 163A-1145.3, a student identification card issued by a constituent institution of The University
37 of North Carolina, a community college, as defined in G.S. 115D-2(2), or eligible private
38 postsecondary institution as defined in G.S. 116-280(3) or an employee identification card issued
39 by state or local government entity that does not contain an expiration date shall be eligible for
40 use in any election held before January 1, 2021.

41 **SECTION 1.2.(h)** Notwithstanding G.S. 163A-1145.1(d)(2), for elections held in
42 2019, any voter who does not present a photograph identification listed as acceptable in
43 G.S. 163A-1145.1(a) when presenting to vote in person shall be allowed to complete a reasonable
44 impediment affidavit and cast a provisional ballot, listing as the impediment not being aware of
45 the requirement to present photograph identification when voting in person or failing to bring
46 photograph identification to the voting place.

47 **SECTION 1.2.(i)** The State Board of Elections and Ethics Enforcement shall
48 develop temporary rules in accordance with G.S. 163A-1309, as amended by this section, no later
49 than July 1, 2019, and permanent rules no later than January 1, 2020. In the development of
50 these rules, the State Board shall consult with Disability Rights North Carolina to develop forms
51 and instructions that are accessible to the disabled community. At least 14 days prior to adoption

1 of the temporary and permanent rules, the State Board shall report to the Joint Legislative
 2 Elections Oversight Committee on the content of the proposed rules. In addition, the State Board
 3 shall report to the Joint Legislative Elections Oversight Committee no later than March 1, 2019,
 4 on the following:

- 5 (1) Any other recommendations to secure the absentee voting by mail process,
 6 including, but not limited, to the following:
 - 7 a. Increasing the potential criminal penalty for violations of that process.
 - 8 b. Increasing training and education for absentee voters by mail.
 - 9 c. Improved technological or administrative methods to ensure the
 10 proper chain of custody of absentee voting by mail.
- 11 (2) Any recommended statutory changes related to security of absentee voting by
 12 mail, including legislation recommended for implementation of subsections
 13 (d) and (e) of this section.

14 **SECTION 1.3.(a)** G.S. 20-37.7 reads as rewritten:

15 **"§ 20-37.7. Special identification card.**

16 ...

17 (d) Expiration and Fee. – A special identification card issued to a person for the first time
 18 under this section expires when a drivers license issued on the same day to that person would
 19 expire. A special identification card renewed under this section expires when a drivers license
 20 renewed by the card holder on the same day would expire.

21 The fee for a special identification card is the same as the fee set in G.S. 20-14 for a duplicate
 22 license. The fee does not apply to a special identification card issued to a resident of this State as
 23 follows:

- 24 (1) The applicant is legally blind.
- 25 (2) The applicant is at least ~~70~~17 years old.
- 26 (3) The applicant or who has been issued a drivers license but the drivers license
 27 is cancelled under G.S. 20-15, in accordance with G.S. 20-9(e) and (g), as a
 28 result of a physical or mental disability or disease.
- 29 (4) The applicant is homeless. To obtain a special identification card without

4 (d2) Notwithstanding subsection (b) of this section, for a person whose valid drivers
5 license, permit, or endorsement, is required to be seized or surrendered due to cancellation,
6 disqualification, suspension, or revocation under applicable State law, the Division shall issue a
7 special identification card to that person without application, if eligible to receive a special
8 identification card, upon receipt by the Division of the seized or surrendered document. The
9 Division shall issue and mail, via first-class mail to that person's address on file, a special
10 identification card pursuant to this subsection at no charge.

12 **SECTION 1.3.(b)** The issuance of special identification cards without application
13 for any person whose valid drivers license, permit, or endorsement is received by the Division
14 upon seizure or surrender, as required by G.S. 20-37.7(d2), as enacted by this act, shall begin no
15 later than May 1, 2019.

16 **SECTION 1.4.(a)** G.S. 163A-1137(a) reads as rewritten:

17 "(a) Checking Registration. – A person seeking to vote shall enter the voting enclosure
18 through the appropriate entrance. A precinct official assigned to check registration shall at once

35 rural, military, veteran, elderly, underserved, minority, or other communities
36 as determined by local needs; and the requirements of North Carolina
37 residency to vote, including applicable intent requirements of North Carolina
38 law, and the penalty for voting in multiple states.
- 39 (8) Notify each registered voter who does not have a North Carolina issued
40 drivers license or identification card a notice of the provisions of this act by
41 no later than September 1, 2019. This notice must include the requirements to
42 vote absentee, early, or on election day and a description of voting by

- 45 (9) Mail information to all North Carolina residential addresses, in the same

49 do not present the required photo identification, and a description of voting

- 30 (1) Obtaining digital photographs of registered voters and verifying identity of
31 those voters, including transfer of digital photographs for registered voters
32 held by the Department of Transportation, Division of Motor Vehicles.
33 (2) Maintaining information stored electronically in a secure fashion.
34 (3) Utilizing electronically stored information, including digital photographs and
35 electronic signatures, to create electronic pollbooks.
36 (4) Using electronic pollbooks to assist in identifying individuals attempting to
37 vote more than once in an election.
38 (5) A proposed plan for a pilot project to implement electronic pollbooks,
39 including the taking of digital photographs at the polling place to supplement
40 the electronic pollbooks.
41 (6) Any other related matter identified by the State Board impacting the use of
42 digital and electronic information in the voting place.

24 serving no less than four hours and provided the list required by this section to be filed by each
25 chair contains the names of all persons authorized to represent such chair's political party. The

27 observers who are residents of that county who may attend any voting place in that county. The
28 chair of each political party in the State shall have the right to designate up to 100 additional

47 director of elections. Individuals authorized to appoint observers must, prior to 10:00 A.M. on
48 the fifth day prior to any primary or general election, submit in writing to the chair of the county

51 place on the day of a primary or general election, the chair shall deliver one copy of the list to

12 may serve at any one-stop site.

15 "(2) If the Postal Service has returned as undeliverable a notice sent within 25 days
16 before the election to the applicant under subsection (c) of this section, then
17 the applicant may vote only in person in that first election and may not vote
18 by absentee ballot except in person under G.S. 163A-1300, ~~163A-1301~~,
19 163A-1302, 163A-1303, and 163A-1304. The county board of elections shall
20 establish a procedure at the voting site for:

35 used as a regular part of the security of the facility that is a voting place or one-stop site."

9 provided to the voter for that purpose in or adjacent to the office of the county

14 **SECTION 3.4.(e)** G.S. 163A-1300(a) reads as rewritten:

15 "(a) Any voter eligible to vote by absentee ballot under G.S. 163A-1295 may request an
16 application for absentee ballots, complete the application, and vote under the provisions of this
17 section and ~~G.S. 163A-1301, 163A-1302~~, G.S. 163A-1302, 163A-1303, and 163A-1304."

18 **SECTION 3.4.(f)** G.S. 163A-1300(i) reads as rewritten:

19 "(i) Notwithstanding the provisions of G.S. 163A-916(a) and (b), a challenge may be
20 entered against a voter at a one-stop site under G.S. 163A-1303 or during one-stop voting at the
21 county board office. The challenge may be entered by a person conducting one-stop voting under

32 members may provide for one or more sites in that county for absentee ballots to be applied for

35 elections whom the board has given training equivalent to that given a full-time employee. Those
36 sites must be approved by the State Board as part of a Plan for Implementation approved by both

39 for Implementation shall include a provision for the presence of political party observers at each

41 on election day. A county board of elections may propose in its Plan not to offer one-stop voting
42 at the county board of elections office; the State Board may approve that proposal in a Plan only
43 if the Plan includes at least one site reasonably proximate to the county board of elections office
44 and the State Board finds that the sites in the Plan as a whole provide adequate coverage of the
45 county's electorate. If a county board of elections has considered a proposed Plan or Plans for
46 Implementation and has been unable to reach unanimity in favor of a Plan, a member or members
47 of that county board of elections may petition the State Board to adopt a plan for it. If petitioned,
48 the State Board may also receive and consider alternative petitions from another member or
49 members of that county board. The State Board may adopt a Plan for that county. The State
50 Board, in that plan, shall take into consideration factors including geographic, demographic, and
51 partisan interests of that county.

1 (b) The State Board shall not approve, either in a Plan approved unanimously by a county
2 board of elections or in an alternative Plan proposed by a member or members of that board, a
3 one-stop site in a building that the county board of elections is not entitled under G.S. 163A-1046
4 to demand and use as an election-day voting place, unless the State Board finds that other equally
5 suitable sites were not available and that the use of the sites chosen will not unfairly advantage
6 or disadvantage geographic, demographic, or partisan interests of that county. In providing the
7 site or sites for one-stop absentee voting under G.S. 163A-1300, ~~163A-1301~~, 163A-1302, this
8 section, and G.S. 163A-1304, the county board of elections shall make a request to the State,
9 county, city, local school board, or other entity in control of the building that is supported or
10 maintained, in whole or in part, by or through tax revenues at least 90 days prior to the start of
11 one-stop absentee voting under these sections. The request shall clearly identify the building, or
12 any specific portion thereof, requested the dates and times for which that building or specific
13 portion thereof is requested and the requirement of an area for election related activity. If the
14 State, local governing board, or other entity in control of the building does not respond to the
15 request within 20 days, the building or specific portion thereof may be used for one-stop absentee
16 voting as stated in the request. If the State, local governing board, or other entity in control of the
17 building or specific portion thereof responds negatively to the request within 20 days, that entity
18 and the county board of elections shall, in good faith, work to identify a building or specific
19 portion thereof in which to conduct one-stop absentee voting under G.S. 163A-1300, ~~163A-1301~~,
20 163A-1302, this section, and G.S. 163A-1304. If no building or specific portion thereof has been
21 agreed upon within 45 days from the date the county board of elections received a response to
22 the request, the matter shall be resolved by the State Board.

23"

24 **SECTION 3.4.(h)** G.S. 163A-1306 reads as rewritten:

25 "**§ 163A-1306. Register of absentee requests, applications, and ballots issued; a public**
26 **record.**

27 The State Board shall approve an official register in which the county board of elections in
28 each county of the State shall record the following information:

- 29 (1) Name of voter for whom application and ballots are being requested, and, if
30 applicable, the name and address of the voter's near relative or verifiable legal
31 guardian who requested the application and ballots for the voter.
- 32 (2) Number of assigned voter's application when issued.
- 33 (3) Precinct in which applicant is registered.
- 34 (4) Address to which ballots are to be mailed, or, if the voter voted pursuant to
35 G.S. 163A-1300, ~~163A-1301~~, 163A-1302, 163A-1303, and 163A-1304, a
36 notation of that fact.
- 37 (5) Date request for application for ballots is received by the county board of
38 elections.
- 39 (6) The voter's party affiliation.
- 40 (7) The date the ballots were mailed or delivered to the voter.
- 41 (8) Whatever additional information and official action may be required by this
42 Part.

43 The State Board may provide for the register to be kept by electronic data processing
44 equipment, and a copy shall be printed out each business day or a supplement printed out each
45 business day of new information.

46 The register of absentee requests, applications and ballots issued shall constitute a public
47 record and shall be opened to the inspection of any registered voter of the county within 60 days
48 before and 30 days after an election in which absentee ballots were authorized, or at any other
49 time when good and sufficient reason may be assigned for its inspection."

50 **SECTION 3.4.(i)** G.S. 163A-1308(c) reads as rewritten:

1 "(c) Delivery of Absentee Ballots and Container-Return Envelope to Applicant. – When
2 the county board of elections receives a completed request form for applications and absentee
3 ballots, the board shall promptly issue and transmit them to the voter in accordance with the
4 following instructions:

- 5 (1) On the top margin of each ballot the applicant is entitled to vote, the chair, a
6 member, officer, or employee of the board of elections shall write or type the
7 words "Absentee Ballot No. ____ " or an abbreviation approved by the State
8 Board and insert in the blank space the number assigned the applicant's
9 application in the register of absentee requests, applications, and ballots
10 issued. That person shall not write, type, or print any other matter upon the
11 ballots transmitted to the absentee voter. Alternatively, the board of elections
12 may cause to be barcoded on the ballot the voter's application number, if that
13 barcoding system is approved by the State Board.
- 14 (2) The chair, member, officer, or employee of the board of elections shall fold
15 and place the ballots (identified in accordance with the preceding instruction)
16 in a container-return envelope and write or type in the appropriate blanks
17 thereon, in accordance with the terms of G.S. 163A-1307(b), the absentee
18 voter's name, the absentee voter's application number, and the designation of
19 the precinct in which the voter is registered. If the ballot is barcoded under
20 this section, the envelope may be barcoded rather than having the actual
21 number appear. The person placing the ballots in the envelopes shall leave the
22 container-return envelope holding the ballots unsealed.
- 23 (3) The chair, member, officer, or employee of the board of elections shall then
24 place the unsealed container-return envelope holding the ballots together with
25 printed instructions for voting and returning the ballots, in an envelope
26 addressed to the voter at the post office address stated in the request, seal the
27 envelope, and mail it at the expense of the county board of elections: Provided,
28 that in case of a request received after 5:00 p.m. on the Tuesday before the
29 election under the provisions of subsection (b) of this section, in lieu of
30 transmitting the ballots to the voter in person or by mail, the chair, member,
31 officer, or employee of the board of elections may deliver the sealed envelope
32 containing the instruction sheet and the container-return envelope holding the
33 ballots to a near relative or verifiable legal guardian of the voter.

34 The county board of elections may receive completed written request forms for applications
35 at any time prior to the election but shall not mail applications and ballots to the voter or issue
36 applications and ballots in person earlier than 60 days prior to the statewide general election in
37 an even-numbered year, or earlier than 50 days prior to any other election, except as provided in
38 G.S. 163A-1300, ~~163A-1301~~, 163A-1302, 163A-1303, and 163A-1304. No election official shall
39 issue applications for absentee ballots except in compliance with this Part."

40 **SECTION 3.4.(j)** G.S. 163A-1310(c) reads as rewritten:

41 "(c) For purposes of this section, "Delivered in person" includes delivering the ballot to
42 an election official at a one-stop voting site under G.S. 163A-1300, ~~163A-1301~~, 163A-1302,
43 163A-1303, and 163A-1304 during any time that site is open for voting. The ballots shall be kept
44 securely and delivered by election officials at that site to the county board of elections office for
45 processing."

46 **SECTION 3.4.(k)** G.S. 163A-1315 reads as rewritten:

47 **"§ 163A-1315. Counting absentee ballots by county board of elections.**

48 All absentee ballots returned to the county board of elections in the container-return
49 envelopes shall be retained by the board to be counted by the county board of elections as herein
50 provided.

51 ...

(6) As each ballot envelope is opened, the board shall cause to be entered into a pollbook designated "Pollbook of Absentee Voters" the name of the absentee voter, or if the pollbook is computer-generated, the board shall check off the name. Preserving secrecy, the ballots shall be placed in the appropriate ballot boxes, at least one of which shall be provided for each type of ballot. The "Pollbook of Absentee Voters" shall also contain the names of all persons who voted under G.S. 163A-1300, ~~163A-1301~~, 163A-1302, 163A-1303, and 163A-1304, but those names may be printed by computer for inclusion in the pollbook.

After all ballots have been placed in the boxes, the counting process shall begin.

If one-stop ballots under G.S. 163A-1300, ~~163A-1301~~, 163A-1302, 163A-1303, and 163A-1304 are counted electronically, that count shall commence at the time the polls close. If one-stop ballots are paper ballots counted manually, that count shall commence at the same time as other absentee ballots are counted.

If a challenge transmitted to the board on canvass day by a chief judge is sustained, the ballots challenged and sustained shall be withdrawn from the appropriate boxes, as provided in G.S. 163A-916(e).

As soon as the absentee ballots have been counted and the names of the absentee voters entered in the pollbook as required herein, the board members and assistants employed to count the absentee ballots shall each sign the pollbook immediately beneath the last absentee voter's name entered therein. The county board of elections shall be responsible for the safekeeping of the pollbook of absentee voters.

(7) Upon completion of the counting process the board members shall cause the results of the tally to be entered on the absentee abstract prescribed by the State Board. The abstract shall be signed by the members of the board in attendance and the original mailed immediately to the State Board. The county board of elections may have a separate count on the abstract for one-stop absentee ballots under G.S. 163A-1300, ~~163A-1301~~, 163A-1302, 163A-1303, and 163A-1304.

...."

SECTION 3.4.(l) G.S. 163A-1368 reads as rewritten:

"§ 163A-1368. Absentee voting at office of board of elections.

Notwithstanding any other provisions of this Subchapter, any covered voter under this Part shall be permitted to vote an absentee ballot pursuant to G.S. 163A-1300, ~~163A-1301~~, 163A-1302, 163A-1303, and 163A-1304 if the covered voter has not already voted an absentee ballot which has been returned to the board of elections, and if the covered voter will not be in the county on the day of the primary or election.

In the event an absentee application or ballot has already been mailed to the covered voter applying to vote pursuant to G.S. 163A-1300, ~~163A-1301~~, 163A-1302, 163A-1303, and 163A-1304, the board of elections shall void the application and ballot unless the voted absentee ballot has been received by the board of elections. The covered voter shall be eligible to vote pursuant to G.S. 163A-1300, ~~163A-1301~~, 163A-1302, 163A-1303, and 163A-1304 no later than 5:00 P.M. on the day next preceding the primary, second primary or election."

SECTION 3.4.(m) G.S. 163A-1411(41) reads as rewritten:

"(41) The term "electioneering communication" means any broadcast, cable, or satellite communication, or mass mailing, or telephone bank that has all the following characteristics:

a. Refers to a clearly identified candidate for elected office.

- 1 b. In the case of the general election in November of the even-numbered
2 year is aired or transmitted after September 7 of that year, and in the
3 case of any other election is aired or transmitted within 60 days of the
4 time set for absentee voting to begin pursuant to G.S. 163A-1300,
5 ~~163A-1301~~, 163A-1302, 163A-1303, and 163A-1304 in an election
6 for that office.
- 7 c. May be received by either:
- 8 1. 50,000 or more individuals in the State in an election for
9 statewide office or 7,500 or more individuals in any other
10 election if in the form of broadcast, cable, or satellite
11 communication.
- 12 2. 20,000 or more households, cumulative per election, in a
13 statewide election or 2,500 households, cumulative per
14 election, in any other election if in the form of mass mailing or
15 telephone bank."

16 **SECTION 3.4.(n)** G.S. 163A-1520(a) reads as rewritten:

17 (a) Judicial Voter Guide. – The State Board shall publish a Judicial Voter Guide that
18 explains the functions of the appellate courts and the laws concerning the election of appellate
19 judges, the purpose and function of the Public Campaign Fund, and the laws concerning voter
20 registration. The State Board shall distribute the Guide to as many voting-age individuals in the
21 State as practical, through a mailing to all residences or other means it deems effective. The
22 distribution shall occur no more than 28 days nor fewer than seven days before the one-stop
23 voting period provided in G.S. 163A-1300, ~~163A-1301~~, 163A-1302, 163A-1303, and 163A-1304
24 for the primary and no more than 28 days nor fewer than seven days before the one-stop voting
25 period provided in G.S. 163A-1300, ~~163A-1301~~, 163A-1302, 163A-1303, and 163A-1304 for
26 the general election."
27

28 **PART IV. APPROPRIATION**

29 **SECTION 4.(a)** There is appropriated from the General Fund to the State Board of
30 Elections and Ethics Enforcement the sum of two million two hundred fifty thousand dollars
31 (\$2,250,000) for the 2018-2019 fiscal year. Of the funds appropriated, the sum of seven hundred
32 fifty thousand dollars (\$750,000) shall be used to implement the provisions of this act and may
33 be used to create temporary positions at the State Board of Elections and Ethics Enforcement.
34 The State Board of Elections and Ethics Enforcement shall transfer to the Highway Fund one
35 million five hundred thousand dollars (\$1,500,000) for the 2018-2019 fiscal year to address the
36 loss of revenues resulting from implementation of this act.

37 **SECTION 4.(b)** There is appropriated from the General Fund to the North Carolina
38 Public Campaign Fund the sum of eight hundred fifty thousand dollars (\$850,000) for the
39 2018-2019 fiscal year. Notwithstanding any other law to the contrary, the State Board of
40 Elections and Ethics Enforcement shall allocate these funds to county boards of elections for
41 maintenance grants for printing equipment or to assist in the implementation of this act.
42

43 **PART V. EFFECTIVE DATE**

44 **SECTION 5.** Except as otherwise provided, this act is effective when it becomes
45 law.
